PROGRAMME ARCHITECTURE

CrAdLE (Centre for Advancing and Launching Enterprises), EDII's Technology Business Incubator set up with the support of Department of Science and Technology, Govt. of India, is focused on incubating startups in the potential areas of food /agri business, renewable energy and healthcare. Till date, 103 startups have been incubated and have raised Rs. 30+ crore fund.

MENTORING & HANDHOLDING

Understanding the importance of mentoring and handholding, budding entrepreneurs are provided support, guidance, and inspirational networking throughout the programme, until they reach a level where they are not only self-sufficient, but in turn are able to do business on their own. Programme facilitates networking with mentors, industry experts, business service providers, besides ensuring access to literature, library, faculty resources and facilities available at EDII for startup innovation and growth.

OPPORTUNITY TO RAISE FUND / GRANT

EDII provides support in raising angel / equity from venture funds and also debt funds from banking system.

Student Startup & Innovation Policy (SSIP)

The Government of Gujarat has developed a Student Startup & Innovation Policy for providing assistance up to INR 2 lac as a support grant for developing Proof of Concepts (POC) for students, innovators, and startups in the idea stage. Further extended support is provided between 2-10 lac under Startup Srujan.

Startup Gujarat

The Government of Gujarat launched Seed Support Assistance under the Startup Gujarat scheme for innovators to provide grant support up to 30 lac for developing prototypes, marketing, testing, and trails. Further extended support is also provided under Sustenance allowance and Social Impact.

MSME Business Incubator (MSME BI)

MSME Business Incubator scheme is to promote & support untapped creativity of individuals and to promote adoption of the latest technologies in manufacturing as well as knowledge-based innovative MSMEs (ventures) that seek the validation of their ideas at the proof of concept level.

Startup India Seed Fund Scheme (SISFS)

The Government of India launched Startup India Seed Fund Scheme (SISFS) under DPIIT to provide support for developing PoC, prototype, marketing, testing & trial, etc. Funding support provided under SISFS consist of the grant and convertible debentures. CrAdLE is one of the nodal centers approved under SISFS.

Ambedkar Social Innovation & Incubation Mission (ASIIM)

Government of India launched the Ambedkar Social Innovation and Incubation Mission (ASIIM) to identify 1,000 SC youth in the next 4 years with startup ideas through Technology Business Incubators (TBIs) in various higher educational institutions. Innovators will be funded @ Rs. 30 lakhs in 3 years as equity funding and successful ventures would further qualify for funding upto Rs. 15 Cr from the Venture Capital Fund for Scheduled Castes.

Ministry of Education's Innovation Cell (MIC) & AICTE

MIC & AICTE will fund 45 innovations from HEIs and provide grant support upto Rs. 10 lakhs per innovation towards refining innovation, building the start up and availing incubation services.


ADMISSION ELIGIBILITY

Graduation (any discipline from university recognized by the University Grants Commission (UGC) / Association of Indian Universities (AIU) / AICTE) with aggregate 50% minimum marks along with the management test score (CAT / MAT / XAT / ATMA / C-MAT).

Final year graduates can also apply for this programme.

Entrepreneurship Development Institute of India (EDII), an autonomous and not-for-profit institute, set up in 1983, is an acknowledged National Resource Institute for Entrepreneurship Education, Research, Training & Institution Building. It is sponsored by apex financial institutions - the IDBI Bank Ltd., IFCI Ltd., ICICI Bank Ltd. and the State Bank of India (SBI). The Government of Gujarat pledged twenty-three acres of land on which stands the majestic and sprawling EDII campus. EDII has been recognized as the CENTRE OF EXCELLENCE by the Ministry of Skill Development and Entrepreneurship, Govt. of India.
